මහා පරිමාණ සංවර්ධන ව්‍යාපෘති වල ප්‍රගතිය

රටේ ආර්ථික ක්‍රියාකාරකම්හි මන්දගාමීත්වයට සෘජුවම බලපාන ලද කොවිඩ් 19 ගෝලීය වසංගත තත්ත්වය 2021 තෙවන කාර්තුව තුළ ද ඉතා දැඩි ලෙස පැවතීම හේතුවෙන්, හුදෙකලා කිරීම් මෙන්ම පළාත් හා දිස්ත්‍රික් සංවරණ සීමා ද පැනවීමට සිදු විය. මෙවන් අභියෝගාත්මක තත්ත්වයන් හමුවේ වුවද රජයේ සංවර්ධන ප්‍රතිපත්ති රාමුවෙහි අන්තර්ගත ඉලක්ක අපේක්ෂිත පරිදි ළඟා කර ගැනීමේ අරමුණ පෙරදැරිව ප්‍රමුඛ සංවර්ධන වැඩසටහන් අඛණ්ඩව ක්‍රියාත්මක විය.

මෙම සංවර්ධන ආයෝජනයන්හි ප්‍රතිඵල අපේක්ෂිත කාලය තුළ ජනනය වීම සහතික වනු පිණිස ව්‍යාපෘති සම්බන්ධයෙන් නිරන්තර අධීක්ෂණය පැවරී ඇති ව්‍යාපෘති කළමනාකරණ හා අධීක්ෂණ දෙපාර්තමේන්තුවෙහි නිරීක්ෂණයන් කාර්තුවය වශයෙන් අවශ්‍ය ප්‍රතිපත්තිමය තීරණ ගැනීම සඳහා අමාත්‍ය මණ්ඩලය වෙත ඉදිරිපත් කෙරේ. ඒ අනුව, එක් එක් රේඛීය අමාත්‍යාංශ විසින් ඉදිරිපත් කරන ලද කාර්යය සාධන තොරතුරු, දත්ත හා ක්ෂේත්‍ර නිරීක්ෂණයන් ද පාදක කරගනිමින් 2021 වර්ෂයේ තෙවන කාර්තුව දක්වා ක්‍රියාත්මක වූ සංවර්ධන ව්‍යාපෘතීන්හි සමුච්චිත ප්‍රගතිය මෙම වාර්තාව මගින් දැක්වේ.

සෞභාග්‍ය ඉදිරි දැක්ම සංවර්ධන ප්‍රතිපත්ති රාමුවෙහි ඉලක්ක අත්පත් කර ගැනීම සඳහා 2021 වර්ෂයේ පළමු කාර්තු දෙක තුළ රුපියල් බිලියන 2,552 ක නව සංවර්ධන ව්‍යාපෘති 88 ක් ආරම්භ කර ඇති අතර, තවදුරටත් තෙවන කාර්තුව තුළද සෞඛ්‍ය, වාරි පද්ධති, වරාය සංවර්ධන වැනි ප්‍රමුඛ ක්ෂේත්‍රයන් ආවරණය වන පරිදි තවත් මහා පරිමාණ සංවර්ධන ව්‍යාපෘති 07 ක් සඳහා රජය විසින් රුපියල් බිලියන 90 ක ආයෝජනය කර ඇත. ඒ අනුව, සමස්ත දළ ඇස්තමේන්තුගත පිරිවැය රුපියල් බිලියන 6,899 ක් වූ මහා පරිමාණ සංවර්ධන ව්‍යාපෘති 322 ක් රේඛීය අමාත්‍යාංශ 47 යටතේ ක්‍රියාත්මක වේ. මෙම ව්‍යාපෘති සඳහා වෙන් කර තිබූ වාර්ෂික මුළු ප්‍රතිපාදනය රු. බිලියන 736 කි. මෙයට අමතරව, 2021 වර්ෂය තුළ රුපියල් බිලියන 39 ක සුළු හා මධ්‍ය පරිමාණ ව්‍යාපෘති 436 ක් සහ රුපියල් බිලියන 31 ප්‍රතිපාදන මත වාර්ෂික සංවර්ධන වැඩසටහන් 152 ක් ක්‍රියාත්මක වේ.

2021 පළමු හා දෙවන කාර්තු සැසඳීමේ දී පැවති බාධාකාරී තත්ත්වයන් හමුවේ වුවද සමස්ථයක් වශයෙන් මෙම ව්‍යාපෘති සැලකිය යුතු කාර්ය සාධන මට්ටමක් දක්වා ඇති අතර, 2021 තුන්වන කාර්තුව අවසන් වන විට අපේක්ෂිත වියදම් ඉලක්කයෙන් 63% ක මූල්‍ය ප්‍රගතියක් අත්පත් කර ගෙන තිබීම විශේෂත්වයකි. මෙය වාර්ෂික ප්‍රතිපාදනයේ ප්‍රතිශතයක් ලෙස සැලකූ විට 40% ක් පමණ වේ. මෙම ව්‍යාපෘතීන්හි වාර්ෂික මූල්‍ය උපයෝජනය පිරිවැය මත වර්ගීකරණය අනුව වගුව 02 මගින් දක්වා ඇත.

நாட்டின் பொருளாதார மந்த நிலைமைக்கு நேரடியான தாக்கத்தினை ஏற்படுத்திய கொவிட் 19 உலகளாவிய வைரஸ் நிலைமை 2021ம் ஆண்டின் முன்றாவது காலாண்டினுள் மிக அதிகமாக காணப்பட்டதன் காரணமாக, தனிமைப்படுத்தல் போன்றே மாகாணம் மற்றும் மாவட்ட பயணத்தடையையும் அமுல்படுத்தவேண்டிய நிலை ஏற்பட்டது. இவ்வாறான சவாலான சூழ்நிலையை சந்தித்த போதும் அரசின் அபிவிருத்தி கொள்கை கட்டமைப்பிற்குள் உள்ளடக்கப்பட்டுள்ள இலக்கை எதிர்பார்த்துக்கப்பட்ட வகையில் அடைந்து கொள்வதற்கான குறிக்கோளினை முன்னோடியாகக்கொண்டு அபிவிருத்தி நிகழ்ச்சித்திட்டங்கள் தொடர்ச்சியாக செயற்படுத்தப்பட்டன.

Progress of Mega Scale Development Projects

Third Quarter- 2021

The COVID-19 global pandemic which has directly influenced the sluggish economic movement of the country relentlessly prevailed well into the 3rd quarter of 2021 were resulted in imposing of travel restrictions among provinces and districts and isolation of localities as well. Even under the effect of these challenges, implementation of priority development programmes has been continued to achieve the targets in the Development Policy Framework of the Government.

In order to ensure the generation of time-bound results delivery of these development projects, the Department of Project Management and Monitoring; as entrusted with the responsibility of regular monitoring; submits its observations on quarterly basis to the Cabinet of Ministers for making appropriate policy decisions. Accordingly, this report presents the cumulative progress of development projects implement up to the third Quarter 2021 based on their information and data provided by respective line ministries as well as field observations.

Investment and Utilization in 2021

With an intention of achieving the targets of the National Development Framework; “*Vistas of Prosperity*”, Rs.2,552 billion worth 88 New development projects have been initiated in first half of the year 2021 while another Rs.90 billion invested in the 3rd quarter for 07 new mega scale development projects covering the priority sectors such as health, irrigation, and ports. Accordingly, approximate total investment of Rs.6,889 billion worth 322 mega scale development projects are being implemented under the purview of 47 line ministries. The total annual allocation for these projects was Rs.736 billion. In addition, 436 medium and small-scale development projects and 152 annual programmes are also being implemented in 2021 by utilizing budgetary allocations of Rs. 39 billion and Rs. 31 billion respectively.

In comparison to the 1st and 2nd quarters of 2021 these projects have shown a considerable level of performance amidst the obstructive situations with a remarkable achievement of 63% financial progress against the expenditure target. This achievement equals to 40% of annual allocation. The Table-02 below illustrates the annual financial utilization of these projects which are categorized based on their total estimated cost.

However, it was reported that, a portion of 2021 annual allocation of 55 mega scale projects which showed slow progress due to obstacles and limitations resulted by the COVID-19 related drawbacks in economic activities in the country, have been transferred to prioritized other projects including mega, small and medium scale projects which need urgent completion. Among those, transfer/ revision of allocated funds from the projects in the road and water supply sectors are prominent.

Even though these fund transfers are considered as timely actions for optimum utilization of annual allocations of development projects, it is observed that these changes would also create an impact on completion of project activities as targeted. The transferred fund should also be fully utilized to make this fund transfer a positive strategy.

2. Physical Progress

A summary of overall performance of 322 projects by the end of 3rd quarter, is illustrated in the Table-03 and; Annexure-A shows the performance of individual projects. Accordingly, it is observed that 14 out of 322 projects are completed by the end of 3rd quarter while 113 (35%) projects are being implemented successfully. However, it has been noted that delivery of results of approximately 60% of projects is uncertain due to various reasons.

3. Extension of Project Period and Revision of Cost

Since the results generation of these projects which are being implemented through an integrated development approach has a significant influence on the results generation of other projects, their completion within the specified timeframe should thoroughly be ensured. It is observed that, 134 on-going projects have obtained extensions to the originally agreed project period. It is reported that, start-up delays, scope changes, poor performance of contractors, delay in third-party approvals and limitations due to COVID-19 pandemic caused these extensions. The total estimated cost of 46 projects have also been increased and delay in project implementation, changes to project scope and unrealistic estimation are among the main reasons for such increases.

Though the extensions related to foreign funded projects are approved by the Cabinet of Ministers, it is observed that the extensions to some of the domestic financing projects have been granted through contract extensions by the Secretaries of respective line ministries. The Committee to Evaluate Changes of On-going Projects (CECOP) which is appointed with an objective to assess the changes of the implementation period and cost estimations of ongoing projects, has approved time extensions of 73 projects since December 2020 up to now. In order to minimize obtaining additional time for project completion, necessity of strengthening the implementation of para 10.3 of the Management Services Circular 01/2019 dated 15.03.2019 on project staff is observed.

4. Completion of mega scale development projects and ensuring benefits

All on-going projects of the 3rd quarter of 2021 should be completed by the year 2030. Fourteen (14) out of 116 projects which are scheduled to be completed in 2021 have already been completed. Another 13 projects have further extended their implementation periods. Accordingly, there are 89 projects which should be physically completed in 2021. 40 projects among those have reached up to 90% of physical progress, showing the probability of completion as planned. Distribution of projects according to the scheduled year of completion is shown in the Table -04.

Progress of 103 projects which are scheduled to be completed in 2021 is illustrated in the Table-05. It is observed that 48 out of these 103 projects (46%) which classified as “*largely deviated from target*” and “*with serious drawbacks in implementation*” are at various progress levels. It is observed that these projects should be completed expeditiously, and action should be taken to make room in the national budget to accommodate new projects that are closely in line with the new development policy framework of the government.

As a whole, a serious intervention by the respective line ministries is required to resolve the dragging of unsolved issues which hinder their progress. Further, requirement of an arrangement to obtain the support of various institutions to clear issues which are beyond the control of project implementing agencies is also observed.

Recommendations:

Since the result generation of these projects which is being implemented through an integrated development approach has a significant influence on the results generation of other projects, their completion within the specified timeframe should thoroughly be ensured. Hence, it is proposed to appoint a permanent committee with the inclusion of the heads of relevant departments in the General Treasury to resolve the frequent issues that cause drawbacks in the implementation of projects.
