Overview

Sri Lanka has been facing tremendous economic, humanitarian and social challenges with a severe recession amid high inflation, depleted international reserves, an unsustainable public debt, and heightened financial sector vulnerabilities. Accordingly, with a view to restore macroeconomic stability and public debt sustainability, safeguarding financial stability, and stepping up structural reforms to unlock Sri Lanka's growth potential, the Government of Sri Lanka (GOSL) entered into a 48-month extended arrangement under the Extended Fund Facility (EFF) of SDR 2.286 billion (about USD 3.0 billion) with the International Monetary Fund (IMF).

Sri Lanka reached a Staff Level Agreement (SLA) with the International Monetary Fund (IMF) in September, 2022 towards restoring macroeconomic stability and debt sustainability. Successful approval of the Extended Fund Facility (EFF) programme by the IMF has also helped to secure additional foreign financing from International Financial Institutions (IFIs). The IMF program targets restoring the country's fiscal sustainability through a well calibrated revenue-based fiscal consolidation plan. Government of Sri Lanka is also committed to implement growth-enhancing structural reforms that will allow Sri Lanka to unlock its full growth. The Sri Lankan Government has also embarked on an ambitious reform agenda to ensure fiscal consolidation, boost tax revenues, rebuild its foreign reserves, improve economic governance, and strengthen the Central Bank's independence. At this juncture, the IMF Executive Board has approved Sri Lanka's IMF program under the Extended Fund Facility (EFF) on 20th March, 2023.

Subsequently, in June 2024 the government of Sri Lanka reached final agreement on its debt treatment with the members of the Official Creditor Committee (OCC) of Sri Lanka's major bilateral lenders, and also signed bilateral debt treatment agreements in relation to the loans owed by Sri Lanka to Exim Bank of China. In September 2024, the Republic reached agreements in principle on the restructuring of approximately USD 14.2 billion of sovereign debt (as of end 2023) with the holders of its International Sovereign Bonds. The successful completion of this bond exchange will enable Sri Lanka to achieve sovereign debt sustainability and accelerate the country's economic recovery. Sri Lanka will achieve approximately USD 9.5 billion debt service payments reduction over the 4-year IMF program period, 31 percent reduction in the coupon rate of Sri Lanka's Bonds to 4.4%, and extension of the average maturity profile of over 5 years. The successful completion of the bond exchange will also normalize relations with bondholders.

Publishing a public debt bulletin will ensure the Government's commitment to transparency, accountability and free accessibility to information by the international organizations, investors and the general public.

This publication depicts the public debt statistics in Sri Lanka as of the end September, 2024.

Total Government external debt as at the end of September, 2024 amounted to USD 38.3 billion. The creditor category-wise composition of external debt is depicted in the following graph;



Commercial debt represents a significant portion of Government external debt which amounted to 38 percent, followed by multilateral debt (33 percent) and bilateral debt (29 percent). About 85 percent of the Commercial category debt consisted of International Bond Issuances (ISBs) and the rest from the Term Financing Facilities (Syndicated Loans). The Asian Development Bank and the World Bank are the major multilateral creditors representing over 87 percent of the total multilateral debt. Under Bilateral debt, 60 percent of its debt represented by non-Paris Club countries while about 40 percent from Paris club countries.
